

£190 was raised for Bolton's Fund.




# **Training**

**20** people gave their time as Bolton CVS volunteer grant assessors during this quarter.



# Refugee and Asylum Seeker Volunteering

Quarter 1, 2024 - 2025

Our Refugee and Asylum Seeker Volunteer Development Officer (RASVDO) has continued engagement meetings, with 6 groups visited: BRASS, Gateway Support, North Bolton Support Group, Precious Gems, Believe Achieve and Bolton Solidarity Community Association. As a result, our RASVDO can support those organisations and their members around volunteering practises and opportunities.

Our RASVDO has built a relationship with Indira, Bolton ESOL Advisory Service Project Lead, to explore delivering bespoke sessions on the Benefits of Volunteering to the Ukrainian and asylum seeker communities.

Our RASVDO is taking a lead on the Positive Pathways programme. The programme is a partnership of 7 organisations that have come together to support people to develop their skills and routes into employment. The programme provides specialised, targeted support for people to overcome complex barriers to employment and engagement in mainstream activity, for example, people with poor mental health, low literacy levels or who are economically inactive. Bolton CVS is the lead partner and BRASS, North Bolton Support Group, Precious Gems, Believe Achieve, BSCA and Gateway Support Group are delivering the support at their venues. # Family Hub and Environmental Volunteering

Quarter 1, 2024 - 2025


**Family Hubs Engagement**: Our Family Hub and Environmental Volunteer Development Officer, Nicola, engaged with 5 Family Hubs across Bolton. Nicola had conversations with 60 individuals, explaining Bolton CVS services and the benefits of volunteering. This has led to volunteer enquiries, successful matches to organisations and support with setting up a group and group development. Further support has been given to 5 groups around providing space to deliver their community activities.

**Environmental Initiatives**: Nicola has built positive partnerships with the VCSE sector:

- 10 groups were offered support via sustainability check-ins, Volunteer Charter and discussions on The Bolton Mark accreditation.
- Referred a member of Four Seasons organisation to our Communications and Impact Development Officer for digital support which will enable the organisation to continue to do what they do best within the community.

## **Wellbeing and Health**

Quarter 1, 2024 - 2025

**Tackling Health Inequalities Conference –** 'It is incredibly important to us at Bolton NHS Foundation Trust to have colleagues from the whole of the VCSE sector collaborating with us in our health inequalities work. Whilst we recognise that our role as an FT is to ensure we address inequalities in access to, outcomes from and experience of the services we deliver, we whole heartedly understand that these areas of inequality are not siloed from the wider determinants of health and wellbeing. With regards to this, we know that we will only make the changes we want to see by collaborating with all our partners who have knowledge and influence in the wider determinants.

The VCSE sector brings a perspective into this work which is different to those of us who have worked in health care all of our careers. And we benefit from that perspective being brought forward in our consideration.

As an anchor organisation in Bolton, we are committed to and benefit from working in partnership with our VCSE sector. We are incredibly grateful for the time that our VCSE sector colleagues give up to take part in our Health Inequality Enabling Group and in our conference.'

Smoking Cessation - harnessing the power and connections of Bolton's VCSE sector, we are now working to help reduce smoking levels across the borough. In Bolton, smoking contributes to an average of 382 deaths per year and more than 2,200 hospital admissions. In partnership with Bolton Council's Public Health team & ABL Health, we are engaging VCSE organisations to help signpost people to the support on offer. Every successful 'quit' not only brings health and financial benefits to the

**Lived Experience Panel** – Bolton NHS Foundation Trust's Lived Experience Panel is all about giving a voice to the public to help shape how we deliver healthcare services. This quarter, training sessions have been held with 4 new members around issues such as quality improvement, equality, equity, diversity and inclusion. We've also held interviews to make the panel more representative of Bolton's diverse communities – 8 new members have now joined the panel.

**Unlocking Wellbeing in Bolton -** Work has continued to identify the barriers faced by carers, particularly those from minority or marginalised communities due to ethnicity or financial hardship. To help build on progress made so far and to ensure maximum impact over the remainder of the project, we've recently commissioned Turn Up the Value to undertake a full evaluation of the work.

# Group visit to Horwich Over 50s Group, undertaken by Tracey McCue, Social Prescribing Link Worker:

#### Visit to Bereavement Cafe

The Bereavement Café runs a monthly pop up service at different venues across Bolton, usually in established cafes, to offer peer support to those dealing with grief and loss.

When Tracey visited the group, it was the day after 33 members of the Bereavement Café had taken part in a 10k run/walk to raise money for their cause. It had been a very successful event with over £3,000 raised!

There was discussion around the Bolton Bereavement Quilt, a piece of creative art, which people can work on as a way of remembering their loved ones.

Understandably, much of the conversation centred on how members of the group are coping, following their individual loss.

Members shared how each person had various hobbies or belonged to groups and how that helped them to cope.

Tracey found this session to be very supportive and informative, and would encourage people who are bereaved to attend.

## Visit to Blackrod Sports and Community Centre

Tracey was shown around the Centre and told the variety of activities that take place.


On this particular day of the visit, the parent and toddler group, Tumble Tots, was taking place with a Warm Space group meeting in another room. When Tracey asked how everyone had got to the community centre, it was heart warming to hear that people who weren't able to make their own way there were brought by another group member. One woman told her that she felt the group had saved her life, as she had been so fed up because she had been stuck in all winter.

Outside, there was the Over 50s Football session and the weekly Walking Group were just setting off. The Over 50s Football Group were a lovely friendly bunch and Tracey chatted to some of the team, including Jim who organises the group.

She was told that most of the team are in their 70s and that the oldest player is 85!

## Development

Quarter 1, 2024 - 2025





In this quarter, **3** organisations have undertaken a 'Health Check'.

**4 groups** are working towards acquiring the Bolton Mark.

**Transforming Lives Group** received a bespoke development session to look into developing their vision, values and members agreement for Transforming Lives Group.



#### Type of support given

In this quarter, **18 types** of support have been given to different groups, organisations, and individuals, including:

Trustee Boards with governance, policy reviews, trustee recruitment, trustee roles and responsibilities and business plans.

Support with access to training, governance review, recruitment, access to funding, GDPR, managing money, safeguarding, cyber security, creating visions and values, risk assessments, registering with the Charity Commission and policy templates.

#### **Social Value**

Our Business Development Manager, Helen, has been working with the Facilities Team to record social value undertaken by The Bolton Hub. We are working with the Growth Company to articulate outcomes. The following has taken place:

- Supported 17 members of the community who came into The Bolton Hub with either the right contact, right place or the right organisation.
- Currently promoting The Lullaby Trust by having a collection box on reception.
- **159 hours** of volunteering undertaken by Bolton CVS Volunteers which is equivalent to **£1,912.80 social value**.
- Bolton CVS staff are encouraged to take part in wellbeing activities, staff have engaged by being part of the Book Club, held twice a quarter, taking part in Weekly Wanders and a one-off Guided Mindfulness session hosted by Dawn, CEO at Bolton CVS.

We have developed a request for Expressions of Interest for a partner to measure the social return on investment (SROI) of the activities of the Bolton's Fund. This is due to go out in quarter 2.

Partnered with the Greater Manchester Business School to host the Greater Manchester Social Value Network in Bolton. Created connections between businesses, VCSEs and social value professionals from across Greater Manchester and highlighted the work of the Bolton Family Social Value Partnership and their aim to generate more social value across Bolton.

Bolton CVS is working with Bolton Council to develop a refreshed Social Value framework for scoring and measuring social value through contracts.

## **Membership**

Bolton CVS is a membership organisation open to voluntary, community and social enterprise organisations.

In total, there are **634 Bolton CVS members**. This number is made up of **560 full members**, and **74 associate members**. **No members** have disbanded in Quarter 1.

2 new full members were approved by the Bolton CVS Trustees. These groups are known as Bolton Black History Group and Light Music Society.

Dave, from Light Music Society, has said this about becoming a member of Bolton CVS: 'Becoming a member of Bolton CVS would give us space to network a lot more in Bolton, have regular updates that we need to run our charity and find additional training.'

#### This quarter:

- 10 workshops delivered to 33 Social Enterprise leaders.
- 3 organisations were supported with the Local Access Partnership (LAP) funding process with 2 organisations completing the application for social investment.
- 3 monthly drop-in sessions held with 9 people attending.
- 2 advice clinics held with attendance by 4 participants.
- 10 Social Enterprises and/or entrepreneurs were given one-to-one support either face-to-face, via email advice or signposted to the social investment fund at Greater Manchester Centre for Voluntary Organisations, to Bolton CVS services and to the various elements of the Proper Good Programme.
- 4 entrepreneurs took part in our tailored business mentoring programme.

#### **Funding Distribution**

The Proper Good Programme is funded by Big Society Capital and Access – The Foundation for Social Investment. It provides locally delivered, free support and social investment for social businesses, social entrepreneurs and social enterprises that aim to make a positive difference to the community. This quarter, we collaborated with The Woodland Trust and took our networking session outdoors and share social enterprise opportunities.

One of our Business Mentoring graduates applied for Proper Good Social Investment, with another two in the pipeline! This is fantastic evidence to show the mentoring programme is helping social enterprises to get support.

## **Business Development**

Quarter 1, 2023 - 2024

Our Business Development Manager, Helen, is working alongside the Funding Team to develop opportunities for local businesses to be involved and invest in the Bolton's Fund 5th Celebration.

Supported Farnworth Town Board to engage with the Farnworth VCSE community in their consultancy phase of planning for the Long Term Plan for Farnworth and supported the VCSE sector to develop Expressions of Interest for projects to be included in the final plan to the government.

Environmental sustainability: 3 applications in progress for grants to improve the energy efficiency of The Bolton Hub.



Bolton CVS received donations to the Bolton's Fund from Tyson Construction and Bolton Wanderers Remembrance Group totalling to £5,500.

Bolton CVS and The Bolton Hub continues to be a centre for community activity and action in Bolton.

We are committed to ensuring accessibility of our services both within The Bolton Hub and within the community.

In this quarter, we had **2,024 visits** to The Bolton Hub.

#### Rent a Desk

The Bolton Hub is offering desk space and a great range of services available to hire on a daily basis. Printing, copying and mail box facilities are available at an additional charge. **4** free room hires provided to 10GM, Health Watch Bolton and Bolton GP Federation.

The Facilities Team are very supportive of service users when coming to The Bolton Hub. An example is helping a member of the U3A group who has difficulty in hearing and walking, the team will support with arranging transport and ensure the process is smooth which will result in the group members having confidence in attending these sessions.

His role covers all general cleaning in The Bolton Hub as well as helping out the Facilities Team with reception and room hire tasks from time to time. # Influential Voice & Collaboration

Quarter 1, 2024 - 2025

### **Voice and Influence**

This quarter, work has continued to further understand our Voice and Influence spaces. As these spaces are starting to become more meaningful and purposeful, we thought now would be a good time to start thinking about insight gathering; what insights we are capturing, how we capture them, and then how we share with the wider Bolton and GM systems. We realise that this is a complex task, with lots of moving parts and lots of ways of working to consider. We also recognise that we cannot do this alone – partnerships and collaboration with both Bolton's VCSE sector and other stakeholders is the key to success.

An example of this is the recent change in name of one of our Voice and Influence spaces. The space has changed from Funding Collaborative to VCSE Collaborative. The attendees of this space felt that it was about much more than applying for funds together. It became about sharing skills, networks, experiences and knowledge of previous collaborative/partnership projects. This insight has been helpful for us to share with our internal Development Team

Another example is looking at a different Voice and Influence space, the Preventative Providers Collaborative. The transferable insight this group collects around community preventative services is unique, and is something that the wider system is beginning to take a real interest in. This quarter, attendees of this space have been invited to speak and network at a variety of public health events or meetings – including the Short–Term Integrated Care Partnership, a Health Inequalities Conference and a Making Every Contact Count workshop. This shows that the work done through this space is being recognised and it has enabled the attendees to make connections and build relationships with a variety of colleagues working across the Bolton health and care system.

The final example is Bolton CVS engaging with GM systems change and leadership training led by the Leadership Centre. Here, representatives are given the opportunity to learn, grow, develop and reflect on blockers/barriers in the system and to try to create the conditions that allow us to drive

collective, focused solutions together.

The main thing we have currently learnt is that networking and relationship building is key to enable effective influencing and our role is to ensure Bolton's VCSE sector gets the opportunities to do so.

### **Partnerships**

Partnership and collaborative working is very important to us at Bolton CVS, as such, members of our team continue to participate in **102** strategic Boards and Partnerships across Bolton and Greater Manchester.

# Workforce Development Project with 10GM

This quarter, we are excited to share the launch of both the GM Workforce and Recruitment Hubs!

The ambition for the <u>GM Workforce Hub</u> is to be a dedicated website to reduce demand and increase the capacity of workforces in this sector. It will host useful information, tools, and resources all in one place, so that it can be easily accessed, and VCSE sector colleagues will no longer have to spend lots of time and resources searching for information, examples of best practice, or training opportunities from across the internet.

The ambition for the <u>GM Recruitment Hub</u> is to be a dedicated website that will host VCSE recruitment opportunities across Greater Manchester. We have now managed to get this hub to communicate with most of the Local Infrastructure Organisations recruitment pages, so we do not need to keep posting opportunities to different websites, with different providers.

This means that recruitment processes will remain the same for the VCSE sector, however, colleagues will be able to add an opportunity to the GM Recruitment Hub and advertise on a GM level to increase reach.

We have already started to socialise this with Bolton's VCSE sector - our Development Team have been directing people to use this as a resource and the Recruitment Hub has been promoted at a variety of fairs where Bolton CVS has had a presence.
