

Hate Crime Awareness Grants 2025

Micro Grants – Up to £500 Total Allocation: £10,000

Closing Date: The fund will close for applications when all the funds are allocated.

Programme Guidelines

Background to the Fund

Bolton's Fund is offering micro grants of up to £500 to Bolton-based, not-for-profit VCSE groups to organize a one-off event or activity promoting Hate Crime Awareness during Greater Manchester Hate Crime Awareness Week in February 2025 (3rd to 9th).

Hate crime is significantly under-reported. Even in difficult times, local groups and organisations need to continue raising awareness of hate crime, challenge hate crime in our communities and help to instil confidence in victims. This will be achieved by highlighting how and where hate crime incidents can be reported.

What is a hate crime?

A Hate Crime is a crime or an incident that is perceived by the victim or any other person as being motivated by prejudice or hatred based on someone's:

- race, colour or ethnic origin
- nationality or national origin
- religion, faith or belief
- gender or gender identity
- sexuality or sexual orientation
- disability
- lifestyle or dress

Hate incidents can take many forms including:

- physical attacks
- threat of attack
- verbal abuse or insults including bullying
- An incident does not have to include violence for you to report it. Verbal abuse, threats or victimisation can be just as distressing and are taken just as seriously.

Funding Priorities

The Hate Crime Awareness micro-grants must be used to fund one-off events or activities that achieve the following:

- Raising awareness and understanding of hate crime and how to report it.
- Encourages victims to come forward and report hate incidents.
- Takes place in Bolton during Greater Manchester Hate Crime Awareness Week in February 2025 (3rd to 9th February 2025).

Some examples of activities that may help achieve the funding priority could include:

- Creative projects like workshops, podcasts, video campaigns, or social media initiatives.
- Activities targeting specific communities disproportionately affected by hate crime.
- Inviting speakers with lived experience to share their stories.

How much money can you apply for?

What can you spend the grant on?

- We cannot fund the purchase of equipment in this funding round. Please make use of the Free Hate Crime Resources available from Bolton Council.

Who is eligible to apply?

The following types of organisations are eligible to apply:

- Constituted voluntary or community groups.
- Registered charities.
- Other not-for-profit organizations (CIOs, CICs, Community Benefit Societies).
- Your organization must be based in or benefit the people of Bolton.
- Must have a bank account in the group's name.
- All applicants and project leaders must complete Bolton Council's Online Hate Crime Training.

Please note: Funding will be allocated on a 'first come, first served' basis and the application form will close when all the funds have been allocated.

Who isn't eligible?

• Local government bodies, schools, NHS bodies, or individuals.

How to Apply:

- Complete the short 'Expression of Interest' form that will be available on the Bolton CVS website in November 2024 (exact date to be confirmed).
- Applications will be accepted on a rolling basis until all funds are allocated.
- Along with the form, submit:
- Recent bank statement (less than 3 months old) with redacted financial information.
- Copy of your group's constitution.
- Safeguarding policy (if working with children or vulnerable adults).

What You Can't Spend the Money On:

- Purchase of equipment. (Use Bolton Council's free resources see below for links)
- Alcohol or promotion of religion.

Important - Monitoring Requirements:

Successful applicants will need to provide the following information about their project:

- A brief explanation of the activity or activities and why they were needed.
- The location/area of Bolton the activities took place.
- When the activity took place.
- Project expenditure details.
- The number of participants/beneficiaries.
- The age of the participants/beneficiaries.
- The ethnicity of the participants/beneficiaries.
- Any feedback or learnings what went well? What could have gone better?
